

Terms & Conditions, Photo Release, and Liability Waiver for Queen ZsaZsa Productions,LLC

FEES/TUITION 2021

****Students get four lessons per month. The tuition rate remains the same regardless of extra days in the month. Those extra days can be used for missed lessons.**

Tuition-Fees/PIANO

\$140 per month/\$35 per lesson-30 minute lesson

\$180 per month/\$45 per lesson-45 minute lesson

\$220 per month/\$55 per lesson-1 hour lesson

Tuition-Fees/Piano Group Classes

\$120 per month/\$30 per lesson-30 minute lesson

\$160 per month/\$40 per lesson-45 minute lesson

\$200 per month/\$50 per lesson-1 hour lesson

PAYMENT DATES: Payments must be made by the first lesson of each month.

No exceptions. If payment is not made at the first lesson for each month, the student will not receive the piano lesson, and there will be a \$40 charge for traveling to student's house for the unexpected cancelled lesson and a \$10 late fee for not paying the tuition on time.

BOOKS/MATERIALS: Books and materials will be purchased by me and reimbursed by the student/parent as needed.

Technology/Instrument:

- Tuned Upright or Grand Piano
- Electric keyboard 61,72, or 88 key
- Electronic device with a webcam-Laptop, cell phone, or ipad- I will need to see a front view of you and another view of your keyboard
- Wifi or Internet because lessons are live streamed

***Note: Preferably 64-88 keys as it pertains to an electronic instrument/keyboard. If your child is a beginning student, please do not purchase a piano until the child has expressed more interest in continuing lessons after a one year commitment**

MISSED LESSONS: If you need to cancel the lesson for any reason, you must give me a 48 hour notice. If a student misses a lesson and it cannot be rescheduled, the tuition for the month remains the same. In other words, the student forfeits the

missed lesson. If the teacher misses a lesson and cannot reschedule the lesson, the fee will be prorated.

TERMINATION: Lessons can be terminated with a 30-day notice. Past fees and current monthly fees must be paid.

DURATION: Lessons begin the first week of August 2021

THE STUDENT SHOULD:

- Practice 3-4 days per week.
- Practice each piece at least 3 times per day.
- Pay serious attention to rhythm, expression/dynamics, tempo/speed, fingering, pedaling, etc.
- Bring all music books and other assigned pieces to every lesson.
- Keep fingernails short, neat, and clean.
- Memorize performance pieces for showcases
- Look at each lesson as a positive challenge, knowing that each lesson can be conquered.

THE PARENT SHOULD:

- Provide an atmosphere conducive for good practice time.
- Provide a properly tuned instrument or electronic keyboard for the practice sessions.
- Listen to the student/child when they are practicing and encourage consistency in their practice.
- Ensure the child attends lessons on a consistent basis.
- Motivate the child to higher levels of attainment in their music lessons.

THE TEACHER SHOULD:

- Present the lessons in a varied and interesting way.
- Encourage the personal strengths and creativity of the students.
- Listen carefully to each lesson, making assessments, then suggestions on how to improve the lesson.
- Motivate the student to a higher level of achievement and attainment in their piano study.
- Notify the parent when there's a lack of consistency in lesson practice or knowledge of concepts to be studied.
